SAILING INSTRUCTIONS

The responsibility for a boat's decision to participate in a race or to continue racing is hers alone. (RRS Fundamental Rule 4)

1 RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS) 2017 2020.
- 1.2 RRS part 2 rules will be replaced with the right-of-way rules of the International Regulations for Preventing Collisions at Sea (IRPCAS) between the times of local sunset and sunrise.
- 1.3 RYA Prescriptions to the Racing Rules of Sailing, available on http://www.rya.org.uk/racing/racingrules/Pages/the-rules.aspx and on the Official Notice Board.
- 1.4 World Sailing's Offshore Special Regulations Category 3 with Category 2 EPIRB, AIS and liferafts.
- 1.5 The rules and regulations of appropriate Class rules; IRC Rules Parts A, B & C; Class40 and MOCRA Rules.
- 1.6 The Notice of Race.
- 1.7 The Sailing Instructions.
- 1.8 RRS 60 is amended: Protests relating to RRS 50.3(c), Outriggers and ERS F1.4 Other Spars shall only be brought by the Organising Authority or International Jury.

Note: The Sailing Instructions shall take precedence over The Notice of Race.

2 EQUIPMENT AND MEASUREMENT CHECKS

2.1 A boat or equipment may be inspected at any time for compliance with the rules and Sailing Instructions.

3 NOTICES TO COMPETITORS

- 3.1 Notices to competitors will be posted on the Official Notice Board located at the Antigua Yacht Club. Notices may be displayed on the RORC website.
- 3.2 Signals made ashore will be displayed from a flag pole in front of the Antigua Yacht Club.

4 SAFETY OFFICER (SUPERYACHTS ONLY)

- 4.1 Each yacht shall designate a Safety Officer and submit his or her name and local mobile phone number to the Race Office at registration.
- 4.2 The Safety Officer must be a member of the afterguard whose primary responsibility will be collision avoidance at the start and have no other responsibility above and beyond safety related matters (collision avoidance, safety communication, navigation, etc.).
- 4.3 The Safety Officer will be responsible for communications on the Bridge to Bridge Safety Channel (VHF Ch.14) and any other communications which enhance the safety of the yacht; This changes RRS 41.

5 ADVERTISING

- 5.1 Yachts shall display advertising supplied by the Organising Authority.
- 5.2 In addition to flying a class flag all yachts shall fly a RORC backstay flag above a class flag. Both flags shall be flown from the backstay or appropriately visible point near the back of boats without backstays, a minimum of 1.5 meters above the deck.

6 OFFSHORE TRACKERS

- 6.1 All boats will be provided with a YB Tracker that must be carried and turned on at all times.
- 6.2 Safekeeping of the YB tracker is the responsibility of the boat owner and must be returned to the race office upon completion of the race. Trackers lost, stolen or mislaid and not returned to the RORC will be charged at £750.

8 IDENTITY GATE

- An Identity Gate will be formed between the Bishop Reef red lateral buoy, approximate position 17° 00′.6N 061° 46′.9W, near the mouth of Falmouth Harbour and a gate boat displaying a blue flag with a RORC logo and a white border, lying approximately one cable to the west.
- 8.2 The gate will be available from 90 minutes before the first start until about 10 minutes after the last start or later at the discretion of the committee. Each boat shall pass once through the gate in a southerly direction with her engine running, displaying her sail numbers and letters secured to the lifelines on the starboard side. In addition a combined lifejacket and safety harness shall be worn by every member of the crew (in accordance with Special Regulations 5.01 and 5.02) and the boat shall receive visual acknowledgement before starting. Warning: Boats which do not pass through the gate correctly are liable to disqualification.
- 8.3 After the start when sail numbers are not displayed elsewhere (sails down) they shall be displayed in the lifelines on the port quarter.

9 NUMBER OF PERSONS ABOARD

- 9.1 Each boat shall **inform the identity gate boat** of the number of persons aboard.
- 9.2 If there are fewer crew than on the Crewlist supplied to the RORC it is imperative that the gate boat be informed of the name(s) of the absent crew. A boat shall not sail with a crew member whose Emergency Contact details have not been lodged with the RORC on the official Crewlist.

10 STARTING TIMES AND SIGNALS

10.1 The race will be started by using RRS 26, with the warning signal being made 10 minutes before the starting signal.

Note: Boats racing under CSA only will start on the 1st Start.

11 STARTING LINE

- 11.1 The starting line is formed between an orange triangle on Fort Charlotte and an orange cylindrical Outer Distance Mark approximately 0.50nm south of Fort Charlotte. The Race Committee may adjust this position with reference to the wind direction on the day of the start. Fort Charlotte is at the eastern entrance to English Harbour above the Pillars of Hercules and below Shirley Heights.
- 11.2 A yellow cylindrical Inner Distance Mark, which is not on the starting line, may be laid.
- 11.3 Boats not yet racing shall stay clear of the Starting Area. Attention is drawn to RRS 23.

12 LATE AT THE START

- 12.1 If a boat which has not previously come to the starting area is not off her moorings at her preparatory signal and comes to the starting area under power or being towed, she shall stop her engine (or drop the tow) and complete a Two-Turns penalty as specified in RRS 44.2 before starting.
- 12.2 No penalty will be imposed for an infringement of RRS 42 whilst complying with Sailing Instruction 12.1. This changes RRS 42 and 45.
- 12.3 A boat starting later than 60 minutes after her starting signal shall notify the Race Committee before starting.

13 AREAS THAT ARE OBSTRUCTIONS

- 13.1 A boat shall not enter an area designated as an Obstruction.
- 13.2 The following are designated as Obstructions:
- 13.2.1The 2-mile exclusion zone on the South West side of Montserrat.
- 13.2.2The exclusion zone off Terre de Bas (Iles de la Petit Terre) for a nature reserve defined by the 10m contour line and marked by buoys.

14 THE COURSE

14.1 The course is detailed in Appendix A

15 COMMUNICATIONS

- 15.1 The Race Committee may broadcast information on VHF Ch.06, Callsign "Ocean One".
- 15.2 Boats are reminded of their legal obligation to keep a continuous watch on VHF Ch.16.
- 15.3 Boats are required to have their onboard mobile phone switched on at all times.
- 15.4 The Race Committee will inform a boat if it requires them to submit progress reports (i.e. in the event of tracker failure).
- 15.4.1When required, progress reports should be delivered by text message (+44 7797 805885) or email (racing@rorc.org).

15.4.2 Progress reports should include:

- Name of boat and Sail Number
- Date/time/mark being rounded
- Course and Speed over the Ground
- Wind Direction and Speed
- Names of any boats nearby
- 15.5 Inter-boat communication calls should when possible be on DSC or VHF Ch.16 as a calling channel and VHF Ch.06 as a working channel.
- 15.6 Boats with communications in addition to VHF should act as a link, taking other boats' reports on VHF and passing them to the Race Committee.

16 TIME LIMIT

16.1 There is no time limit for the race.

17 THE FINISH

- 17.1 All boats are requested to listen on VHF Ch.06 from 5 miles off and call "Ocean One" to assist with identification when 1 mile from the finish
- 17.2 The Finishing Line will be formed between the flagstaff on Fort Charlotte and an orange cylindrical buoy which may have a flashing yellow light at night. The buoy will be in approximately the same position as the ODM at the start of the race, approximately 0.6nm south of Fort Charlotte.
- 17.3 To aid with identification, when finishing at night, boats are required to shine a spotlight on their sail numbers and call "Ocean One" on VHF Ch.06 immediately after finishing.
- 17.4 Boats are reminded to take their own finishing times together with the names of the boats ahead and astern, if any. Finishing times shall be delivered to the RORC as soon as possible using a Declaration Form.

18 RACE FINISH DECLARATIONS

- 18.1 After finishing or retiring, boats shall complete and submit a Declaration Form to the Race Committee together with the YB tracker as soon as possible, but **not later than 24 hours after the end of the race**. Every member of the crew shall sign the Declaration Form. Failure to comply with this rule may result in the boat being excluded from the results. When a boat retires from a race she shall write the reasons on her Declaration Form.
- 18.2 When after a race a boat cannot promptly deliver the Declaration Form she shall without delay telephone the Race Committee, confirm that she has finished racing and give her time of finishing. In this case the completed Declaration Form may be scanned and emailed to racing@rorc.org. The YB tracker must also be returned.
- 18.3 Failure to return the YB tracker at the conclusion of the race will incur a £750 charge.

19 RETIREMENTS AND NON STARTERS

19.1 Retirements and non-starters must promptly inform the Race Committee or **ABSAR**. It is imperative that boats that are no longer competing can be excluded from any Search and Rescue operation. **Failure to comply with this rule may lead to disqualification or exclusion from future RORC racing.**

20 USE OF ENGINE

20.1 When a boat uses its engine, e.g. to avoid collision, in a grave emergency, or as per SI 21 Temporary Discontinuance of Racing, the facts shall be reported on her Declaration Form.

21 TEMPORARY DISCONTINUANCE OF RACING

- 21.1 If a boat temporarily stops racing, they shall immediately inform the Race Committee explaining the circumstances and their plan by text message (+44 7797 805885) or email (racing@rorc.org).
- 21.2 If a boat makes fast in order to take shelter or in an emergency, the crew may temporarily leave the boat to handle her moorings. If she uses her engine for propulsion she shall, on re-joining the race, return to the spot where she began to use her engine, turn off her engine and continue to race from that spot. She shall report the circumstances on her Declaration Form. This changes RRS 45 and 47.2.

22 PENALTY SYSTEM

- 22.1 Scoring Penalty:
- 22.1.1 When the right-of-way rules of IRPCAS apply (between the hours of local sunset and sunrise) a scoring penalty applies (RRS 44.3).
- 22.1.2 The scoring penalty will be 10 minutes added to the boat's corrected time for each penalty.
- 22.1.3 When a scoring penalty does not apply, a yacht may take a Two Turns Penalty for breaking a rule of RRS Part 2 or a One Turn Penalty when she may have broken RRS 31, as described in RRS 44.2.
- 22.2 Standard Penalties:
- 22.2.1When at a boat's starting signal she is subject to RRS 29.1 Individual Recall and she fails to comply with RRS 29.1 to start correctly, the Race Committee shall, without a hearing, apply a standard time penalty of 20% and she shall be deemed to have started correctly. This changes RRS63.1 and A5.
- 22.2.2For a breach of RRS 28 (Sailing the Course) the Race Committee shall, without a hearing, apply a standard time penalty of 20%. This changes RRS63.1 and A5.
- 22.2.3For a breach of any area designated an Obstruction the Race Committee shall, without a hearing, apply a standard time penalty of 20% unless the breach was unavoidable and unintentional and no advantage was gained. This changes RRS63.1 & A5.
- 22.2.4Should the Race Committee consider a standard penalty to be inappropriate, it shall protest the boat.
- 22.2.5If, in a valid hearing brought by the Race Committee under Sailing Instruction 22.2.4, or by another boat, a boat is found to have infringed RRS 28, 29.1 or Sailing Instruction 13 the penalty will be at the discretion of the Protest Committee, but will not be less than the standard penalty.
- 22.3 Grounds for Protest:
- 22.3.1Breaches of SI 5, 0, 18 will not be grounds for protest by a boat. This changes RRS 60.1a.
- 22.4 Other Penalties:
- 22.4.1When the Protest Committee decides that a boat, that is party to a protest hearing, has broken a rule other than RRS Part 1 and 2 and that no serious damage or injury was caused, and no significant advantage has been gained, the penalty shall be at the discretion of the Protest Committee.

23 PROTESTS AND REQUESTS FOR REDRESS

- 23.1 Protests may be written on plain paper, but Protest forms are available at the Race Office. Protests and requests for redress or reopening shall be delivered there within the appropriate time limit.
- 23.2 The protest time limit is 3 hours after the protesting boat finishes.
- 23.3 Notices will be posted no later than 30 minutes after the protest time limit for the last boat to finish the race.
- 23.4 The notification of a Protest by the Race or Protest Committee against a competitor as required under RRS 61.1(b) or (c) shall consist of a notice on the Official Notice Board at the finish.

24 SCORING

- 24.1 The Scoring System for the race, defined in Notice of Race 14.1, will apply. The scoring system will be the High Points System as detailed in the notice of race.
- 24.2 RRS Appendix A is changed; paragraph A4 will not apply.
- 24.3 Points will be multiplied by the Points Factor of 1.4 when applied to the RORC Season's Points Championship.
- 24.4 A boat that is penalised under RRS 30.2 or that takes a penalty under RRS 44.3(a) shall be scored points as provided in RRS 44.3(c).

25 TROPHIES AND PRIZES

25.1 The following Trophies and prizes will be awarded:

The FKG trophies will be won by the first monohull and first multihull to cross a line running through the Proselyte Reef, a West Cardinal Pillar Lt Buoy, Q(9) 15s and the light house on the end of the cruise pier, Iso.2s 7m. 26 MEDALLIONS:

- 26.1 RORC medallions will be presented as prizes for each class and division
- 26.2 When there are fewer than 6 starters in a class it may be combined for prizes with a neighbouring class.

27 RISK STATEMENT

- 27.1 Rule 4 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."
- 27.2 Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
 - a) they are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
 - b) they are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
 - c) they accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission;
 - d) their boat is in good order, equipped to sail in the event and they are fit to participate;
 - e) the provision of a race management team and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
 - f) they are responsible for ensuring that their boat is equipped and seaworthy so as to face extremes of weather; that there is a crew sufficient in number, experience and fitness to withstand such weather; and that the safety equipment is properly maintained, stowed, in date and familiar to the crew.

28 INSURANCE

28.1 Each boat shall ensure that their boat is adequately insured, against all third party claims.

29 RIGHTS TO USE NAME AND LIKENESS

29.1 By participating in this event, competitors automatically grant to the Organising Authority and the event sponsors the right, in perpetuity, to make, use, and show, at their discretion, any photography, audio and video recordings, and other reproductions of them made at the venue or on the water from the time of their arrival at the venue, until their final departure, without compensation.
